Completing the Application

- ✓ The Club membership year is July 1st to June 30th. Dues will be pro-rated according to the month in which you join. Initiation fees are due in full. Rates are subject to change.
- ✓ Both initiation fees and dues are subject to New York sales tax of 8.875%.
- ✓ ALL requested information must be filled out in order to process your application.
- ✓ All checks should be made payable to **The Penn Club** and to the attention to the Membership/Admissions Office. Credit card payment is accepted.
- ✓ Applications may be dropped off at the front desk, mailed, scanned & emailed or faxed to the attention of the Membership/Admissions Office at (212) 403-6616. If the application is faxed, the original signed application should be mailed to the Membership Office for record keeping.
- ✓ Verification of the information on the application will be conducted during the membership acceptance process.
- ✓ Annual dues and initiation fees are determined upon thorough review of the information provided. Any additional charges that are determined by the membership department must be paid for in advance before the membership process can be completed.
